Learning About AskRail

Important

Upon arriving at a rail incident, an emergency responder should first attempt to locate the train's conductor and get the train consist, which is a document that describes the make-up of the train. If the conductor is not available, the emergency responder can obtain the train consist by contacting the railroad directly.

The emergency responder can also use the AskRail® mobile application on their mobile device to query the Equipment ID for a specific railcar to find out its contents.




AskRail displays the last known information about railroad equipment contents. This information is expected to be current and correct; however, it may not be due to various data quality impediments or delays in data transmission. It is recommended that emergency responders use AskRail temporarily for safety isolation, evacuation, and/or assessment from a distance while securing the proper shipping paper. The train consist or waybill should be secured before offensively approaching the railcar. The AskRail application should only be utilized by industry-qualified hazmat emergency responders.

Note: The sequencing of the cars in the application may not match the sequencing of the cars on the paper consist, which is the compliance document and takes precedence in any discrepancy.

Overview

AskRail IRD is a free application, available through the www.AskRail.us, which provides immediate access to accurate, near real-time information about railcars carrying hazardous materials on a train. It serves emergency responders who arrive first to the scene of a rail incident and helps them make informed decisions about how to respond to a rail incident.

Because certain information available through AskRail is sensitive, only qualified users and users who have completed industry-sponsored training for emergency responders, have registered their mobile device, and have validated their email address with Railinc can gain full access to the railcar lookup functionality and "Top 125" feature. Note that the railcar lookup functionality should only be used for actual emergency situations and/or training purposes.

As an emergency responder and authorized user, you can use AskRail to:

- Query the contents of a railcar with a simple Equipment ID search to see whether a railcar is carrying hazardous materials. AskRail returns the following information:
 - Loaded or empty status
 - Weight of the shipment
 - United Nations/North America (UN/NA) Identification Number for any located hazardous materials
 - Proper shipping name (PSN) for the railcar's contents
 - Technical name of hazardous materials (if available)
 - Hazard class for the railcar's contents
 - Poison Inhalation Hazard information (if applicable)
 - Railroad name
 - Railroad's emergency contact information
- View information about locomotives and end-of-train devices, including the fuel capacity and traction type of locomotives.
- Read published guidance about how to respond to situations involving any located hazardous materials.
- Look up information about hazardous materials placards.
- Calculate the isolation zone and display the affected area on a map.
- Read published guidance about isolation zones for certain hazardous materials.
- View a list of the Top 125 hazardous materials most commonly shipped via rail as reported in the latest AAR/BOE Annual Report of Hazardous Materials Transported by Rail. This list represents aggregated data from the North American freight rail industry, measured by loaded tank car originations during a calendar year.
- Access emergency contact phone numbers for all Class I railroads (the largest freight railroads) as well as Amtrak passenger railroad and available Short Line railroads.
- Access contact information for Emergency Response Resources.

ECC users are granted *Consist Lookup Access* for AskRail, which enables users to see information about individual railcars plus view the full consist details (i.e., it returns information for all railcars on a train). System Requirements

AskRail Internet Ready Device requires the Windows operating system version 7 or higher. **Note:** For security purposes, the .exe file is signed, and the downloaded file can be verified using the hash on AskRail.us.

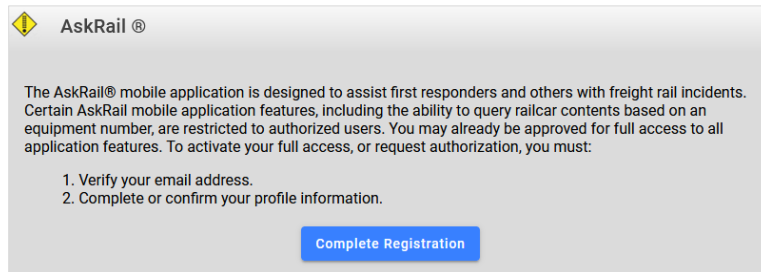


Installing AskRail IRD for an ECC

These instructions describe how to set up AskRail IRD on a Microsoft Windows computer in your Emergency Communications Center (ECC) dispatch center. Once you install AskRail IRD on your first dispatch center computer, you can then use this procedure to install it on the rest of the Windows computers in your dispatch center.

1. Determine the email address to use. To set up AskRail IRD for the ECC, it is best to have one email that can be accessed by multiple people (although this is not required). This email will receive the email verification links when you sign into a new computer. **Note:** ECCs have created a new generic shared email if they did not already have one.
2. Go to [AskRail.us](https://askrail.us), scroll down to the "How to Request Full Access to the App" section, and select the link for the Windows Desktop Application version of AskRail to download AskRail IRD on your first dispatch center computer. Select/open the downloaded .exe file. The Complete Registration page is displayed.



3. Select **Complete Registration**. The Verify Email page is displayed.
4. Enter the ECC Name as the First/Last Name (split the ECC name over these two fields as shown in the example above). Next, enter the email address from step 1 in the Email Address and Confirm Email Address fields and select **Verify My Email**.

5. Open the email address from step 1 and select the email verification link that was sent. **Note:** After selecting the link, if you see a page with "Error: Invalid Code", be assured that the verification did work. Simply ignore the error and close the page.
6. Open or go to the AskRail IRD app on your computer, select the vertical ellipsis (⋮) in the top right corner, and select **Profile**. Your profile should have the status of "Email Verified".
7. Select **Complete Registration**. The Edit User Profile page is displayed for you to complete your registration (the top portion of this page is shown below).

8. Complete all of the required fields.
 - For the First/Last Name fields, split the ECC name over these two fields as you did previously.
 - For the Email Address field, enter the email address from step 1.
 - For the Category field, select **Other** (there will be an ECC option in the future).
 - For the Sponsor field, choose any railroad. Railinc will update your sponsor to AAR when your access is approved.

9. Select both toggles in the Sign Form section at the bottom of the Complete Registration page (the bottom portion of this page is shown below).

10. Select **Submit**. Once you have registered, your status should be "Authorization Pending".
11. Contact Railinc and provide the email address you used to create your account. Railinc will ensure your account is approved for access in a timely manner. Once approved you will have access to use AskRail IRD.
12. After your access has been approved, open the AskRail IRD app on your computer.
13. Verify your access by selecting the vertical ellipsis (⋮) in the top right corner and selecting **Profile**. Your profile status should be listed as "Consist Lookup Access".

Use the following steps to download AskRail IRD on the rest of your dispatch computers:

14. Go to [AskRail.us](#), scroll down to the “How to Request Full Access to the App” section, and select the link for the Windows Desktop Application version of AskRail to download AskRail IRD on each remaining dispatch center computer. Select/open the downloaded .exe file. The Complete Registration page is displayed.
15. Select **Complete Registration** and sign in using the same email and password you set up on your first computer. An email verification link should be sent to the same email address.
16. Select the email verification link.
17. Open the AskRail IRD app on your computer.
18. Verify your access by selecting the vertical ellipsis (⋮) in the top right corner and selecting **Profile**. Your profile status should be listed as “Consist Lookup Access”
19. Repeat steps 14-18 for all the computers on which you need to install AskRail.
